I am to inform that Sri P.Rajalingam, orthopaedically disabled person working as Assistant Professor, Central University of Karnataka State vide his representation 1st cited is requesting for (i) constitution of a Centre for Disability Resources in all Central, State and Deemed to be Universities in the State of Telangana in consultation with the State Commissioner for PwDs under RPwD Act, 2016 as Mentor, (ii) implementation of 5% reservation in admissions in very course, (iii) to inclusion of the Disability Rights subject in the academic curriculum, (iv) Equal Opportunity Policy for PwDs as per provisions of Section 32 & 47 of the RPwD Act, 2016 as per directions of Hon'ble Supreme Court of India and UGC.

Government of India enacted the Rights of Persons with Disabilities Act, 2016 while came into force from 19.04.2017.

Section 32 of Rights of Persons Disabilities Act, 2016 reads thus:

32. (1) All Government institutions of higher education and other higher education institutions receiving aid from the Government shall reserve not less than five per cent. Seats for persons with benchmark disabilities.

(2) The persons with benchmark disabilities shall be given an upper age relaxation of five years for admission in institutions of higher education.

Sec. 47(2) stipulates all Universities shall promote teaching and research in disability studies including Establishment of Study Centres for such Studies."

Further, Government of India, Ministry of Social Justice and Empowerment vide their release No. No.3-1/1993-DD.III, dated: 16.02.2006 released the National Policy for Persons with Disabilities and suggested that the Government, Non Governmental Organisations and experts would take necessary steps in implementation of this policy to improve the quality of the life of persons with disabilities. In the National Policy, Government of India made various suggestions in various fields of society for better development of persons with disabilities including education. Para No. II B at item No. 26 and 27 it is stated that

26. Facilities for technical and vocational education designed to inculcate and bolster skill development suited to various types of productive activities by adaptation of the existing institutes or accelerated setting up of institutes in unserved/underserved areas will be encouraged. NGOs will also be encouraged to provide vocational training.

27. Persons with disabilities will be provided access to the Universities, technical institutions and other institutions of higher learning to pursue higher and professional courses.

The Hon'ble Supreme Court, in their orders dated:25.04.2017 in IA No. 10 of 2015 in Writ Petition (Civil) No. 116 of 1998 and at para No. 24 of the orders, the Hon'ble Supreme Court directed the Union Government, the State Governments and Union Territories to take immediate steps to comply with the requirements of the 2016 Act and file the compliancereport so that this Court can appreciate the progress made. Also the Hon'ble Supreme Court passed orders dated: 15.12.2017 in WP (Civil) No. 292 of 2008 for implementation of 5% reservation for persons with disabilities in admissions in all educational institutions including universities.

Based on the instructions issued by the Ministry of Human Resource Development, Department of Higher Education, New Delhi, the Under Secretary, University Grants Commission vide their F. No. 6-5/2017(SCT), dated: 19.01.2018 requested all the Registrars of Central, State and Deemed Universities to furnish the action taken report on the following recommendations:

- To issue appropriate instructions for implementation of reservation of 5% of seats in every Government and Government aided higher educational institutions in terms of Section 32 of the Act.
- To workout mechanism for orientation and sensitization at college and university level regarding rights of PWDs in terms of Section 39 (2), and also to include rights of persons with disabilities in the curriculum in the colleges and universities in terms of Section 39 (2) (f) of the Act.
- To issue general instructions to all the establishments under its control regarding implementation of other provisions of the Act.
- Chapter III of the above mentioned Act have provisions listed for Education sector.

The Secretary and the Joint Secretary, UGC, New Delhi vide their letters 10th and 11th cited respectively requested all the Grants-in-Aid institutions / Registrars of all Universities to implement the following instructions issued by the Hon'ble Supreme Court of India in WP No. 292 of 2008.

- To form an Internal Committee comprising teachers, staff, students and parents taking carer of day to day needs of differently abled persons as well as for implementation of the schemes existing and to be divised in future.
- To report the proper functioning of Equal Opportunity Cell in the Colleges, Universities and other higher education institutions.

In view of the above, it is requested to initiate immediate steps for (i) for constitution of Internal Committee for Students with Disabilities, (ii) to establish Centre for Disability Resources in consultation with the State Commissioner for PwDs under RPwD Act, 2016 as Mentor, (iii) implementation of 5% reservation in admissions in every course, (iv) inclusion of the Disability Rights subject in the academic curriculum, (v) Equal Opportunity Policy for PwDs as per the provisions of Section 32 & 47 of the RPwD Act, 2016 and the directions of Hon'ble Supreme Court of India, besides the instructions of the University Grants Commission (UGC). It is also requested to nominate the following persons with disability as members in Internal Committee to pursue the problems of the students with disabilities and for their redressal.
