Establishment – Allowances – Dearness Allowance – Enhancement of Dearness Allowance to the University Teaching and Non-teaching employees, including Time-Scale Employees, with effect from 01/07/2019 – Sanction – Orders – Issued.

The State Government has issued orders vide G.O. 3rd cited, revising the rate(s) of Dearness Allowance sanctioned under reference 1st cited and implemented by the University vide reference 2nd cited, to the State Government employees including teaching and non-teaching employees of the Universities in the State with effect from 1st July, 2019, subject to the conditions as prescribed in the above said orders. The details of revision of Dearness Allowance are as follows:

Based on the G.O. 3rd cited, the Vice-Chancellor has accorded approval for implementation of the above said revised rates of Dearness Allowance to the teaching and non-teaching employees, including Time-Scale Employees of the Kakatiya University as per the terms and conditions as stipulated by the State Government from time to time in this regard.

All the Drawing & Disbursing Officers, K.U., are directed to take necessary action as per the provisions of the G.O. 3rd cited above and prefer the claims for payment of Dearness Allowance of the employees concerned accordingly.

Further, on account of the implementation of the said G.O. 3rd cited, Dearness Allowance shall be paid in cash with the salary of **November**, 2020 payable on 1st **December**, 2020. The arrears on account of payment of Dearness Allowance for the period *from 01/07/2019 to 31/10/2020* shall be credited to the **GPF Account** of the respective employees, only after the release of the grant(s) by the State Government. In respective of Full Time Contingency/ Time-Scale Employees, the arrears may be paid in cash with the salary for the month of **November**, 2020 payable on 1st **December**, 2020.

The Audit Officer (Pre-Audit), KU, shall ensure that the terms and conditions prescribed in the G.O. 3rd cited above are scrupulously followed by the Drawing Officers while claiming the amount in this regard.

The Revised Dearness Relief shall be paid along with the pension of November, 2020 payable in the month of December, 2020. However, the arrears of revised Dearness Relief to the Pensioners from 01.07.2019 to 31.10.2020 shall be paid in four euated installments starting from December, 2020.
