### Constitution Rule 3 b - Associate Fellows

An "Associate Fellow" shall have a post-graduate degree in S & T. Application for the Associate Membership shall be supported by three full members and approved by the Council. Such members shall have the right to use the library, reading room, to attend the lectures, symposia, seminars and attend the meetings where papers are read. But they have no right to vote and they cannot take any part in the administration of the Academy nor can they take part in the business meetings of the Academy.

### Constitution Rule 3 c - Companion Members

Those who are actively interested in the 'objects of the Academy' may be accepted by the Academy application as 'Companion Member', supported by two Full Members (Fellows) and approved by the Council. They shall have all the rights and privileges of Associate Members. Science Teachers from different educational institutions may be admitted on application under this category.

### Instructions to the Proposer

- Nomination in case of Associate Fellowship shall be made by a Fellow of the Academy duly supported by two Fellows of the Academy.
- Nomination in case of admission as Companion Member shall be made by two Fellows of the Academy.
- All entries in the nomination form should be completed. The Nomination not complete in all respects is liable to be rejected.
- The original nomination form duly signed by the three Fellows of the Academy and three of its xerox copies along with three copies of the nominee's list of publications and one set of reprints of five most important publications are to be sent to the Academy.
- The nominations for the year 2020 are to be sent by a Fellow of the Academy, so as to reach not later than **5<sup>th</sup> March 2021** to the office of the Telangana Academy of Sciences, O.U. Qtr. No. L-68, Besides International Hostel, Tarnaka, Hyderabad - 500017.
