FOR ADMISSION INTO Ph.D. PROGRAMME UNDER CATEGORY – I (Research Fellowship holders and Candidates with M.Phil. awarded in Regular Mode) for the Academic Year 2021-2022. The following subjects viz., Botany, Bio-Technology, Chemistry, Computer Science, Geology, Mathematics, Microbiology, Physics and Zoology.

In pursuance of KU Letter No.1623/B3/KU/2021, dated 20-12-2021, from the Registrar, Kakatiya University, Warangal, applications are invited from the eligible candidates for admission into Ph.D. Programme under Category-I (Research Fellowship holders and candidates with M.Phil awarded in Regular Mode) for the academic year 2021-2022, in the Faculty of Sciences, Kakatiya University, Warangal.

The Rules & Regulations of Ph.D. Program (*As amended in terms of UGC Regulations 2016*) with effective from 2017-2018 onwards and adoption of Ph.D. rules by the University shall be followed to make Ph.D. admissions for academic year 2021-2022 under Category–I.

I. Eligibility:

Eligibility as per Ph.D. Rules and Regulations of the University w.e.f., 2017-2018 onwards (pp.3-4) under Category - I:

All the Faculties (Arts, Commerce & Business Management, Education, Engineering & Technology, Law, Pharmaceutical Sciences, Sciences and Social Sciences), a candidate is eligible for admission into Ph.D programme in the respective subject, if:

2.1 The candidates should have a Master's degree in the concerned subject or a professional degree declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed).

A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/ Differently-Abled and other categories of candidates as per the decision of the Commission from time to time, or for those who had obtained their Master's degree prior to 19th September, 1991. The eligibility marks of 55% (or an equivalent grade in a point scale

wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible based only on the qualifying marks without including the grace mark procedures.

OR

An equivalent degree from a Foreign Educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions.

2.2 Candidates possessing a M.Phil Degree (Under Regular mode) of an Indian Institution or from a Foreign Educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions, shall be eligible for admission to Ph.D. programme.

OR

A person whose M.Phil Dissertation has been evaluated and the viva voce is pending may be admitted to the Ph.D. programme of the same Institution (Only applicable to an Integrated Programme of Ph.D. in the same Institution, if any).

ADMISSION PROCESS into Ph.D. PROGRAMME

The Admissions into Ph.D Programme is made in Two categories: (1). Category-I and (2) Category-II. The seats under Category-I shall be restricted to fifty per cent (50%) of the available vacancies as on the date of notification of Category-I. The leftover fifty per cent (50%) seats shall be reserved for Category-II candidates.

CATEGORY I: CANDIDATES REGULAR MODE: RESEARCH FELLOWSHIP HOLDERS AND
WITH M.PHIL, AWARDED IN

A). Eligibility and other conditions:

- 1. Master's Degree holders satisfying the criteria stipulated under the Clause 2 (2.1 to 2.4) of the above.
 - 2. The candidates who have been awarded a research fellowship, either through a National Level Test / National Funding Agency conducted by national level organizations such as:
 - (i) UGC-JRF)/CSIR -JRF/ DBT-JRF/ ICMR-JRF/ DST-INSPIRE fellowship/ Teacher Fellowship holder (QIP of AICTE or FIP of

UGC)

OR

(ii) Qualified in the UGC-NET/CSIR-NET/SET-AP-TS/JEST/Valid GATE/ examinations.

OR

(iii) M.Phil Degree awarded in regular mode.

B). Admission Process for Category-I

- 1. The eligible candidates are requested to obtain Prescribed Application from the Office of the Dean, Faculty of Sciences, Kakatiya University, Warangal.
- 2. The prescribed Registration fee of Rs. 3000/- (Rupees Three Thousand only) is for all others and incase of SC/ST/OBC (non-creamy layer)/ Differently Abled candidates Rs. 2000/- (Rupees Two Thousand only) may be paid through Net Banking/Debit/Credit cards into the Registrar Income Account No. 520269-11837, IFSC Code- SBIN0020262, Kakatiya University Branch, Hanamakonda.
- 3. The candidate has to submit the filled-in application along with all necessary enclosures such as Academic & Research performance records (Memos, Provisional/Convocation certificate copies), Latest Caste Certificate (if applicable), Aadhar Card copy and submit a comprehensive research proposal of 5 hard copies and a soft copy.
- 4. Admission into Ph.D. programme is subject to rules and regulations in force from time to time and admissions are subject to the availability of vacancies.

The last date for receipt of applications along with all enclosures including Research Proposal and copies of Research Papers at the Dean's office is 20-01-2022 by 5 pm.
