Applications are invited from the candidates desirous of appearing for the Telangana State Integrated Common Entrance Test (TSICET-2022) for admission into Master of Business Administration (MBA) / Master of Computer Applications (MCA) course (full-time/part-time/evening/distance mode/ Open Distance Learning) offered by the Universities in the State of Telangana for the academic year 2022-23 to be conducted by Kakatiya University, Warangal (as per G.O. Ms No. 25, dated: 19.3.2004; G.O.Ms.No.108 dated 30-7-2005; G.O.Ms. No. 66, dated 15-7-2011; G.O.Ms. No.5, dated 2-8-2014; G.O.Ms. No.7, dated 5-8-2014; G.O.Ms. No.33 dated 31-12-2014 and its amendments and G.O. ELIGIBILITY CRITERIA TO APPEAR FOR TSICET - 2022

- 1. The candidate should be an Indian National and should satisfy local/non-local status requirements laid down in G.O. Ms No. 25, dated: 19.3.2004; G.O.Ms.No.108 dated 30-7-2005; G.O.Ms. No.66, dated 15-7-2011; G.O.Ms. No.5, dated 2-8-2014; G.O.Ms. No.7, dated 5-8-2014; G.O.Ms. No.33 dated 31-12-2014 and its amendments and G.O. Ms. No. 22, dated 27.07.2019 of Higher Education Department of the Government of Telangana and its amendments.
- 2. The candidates other than Indian nationals should satisfy the rules of the Universities concerned.
- 3. The minimum age of the candidates should be 19 years as on the date of notification (Candidates who borne on or before 30th March, 2003). No maximum age limit.
- 4. The candidates seeking admission in to:
 - a) Master of Business Administration (MBA): Should have passed recognized bachelors degree (B.A/B.Com/B.Sc/BBA/BBM/BCA/BE/B.Tech/B. Pharmacy and any 3 or 4 year degree except Oriental Languages) examination of minimum three years duration with at least 50 per cent marks (45 per cent marks in case of reserved categories) in the qualifying examination.
 - b) Master of Computer Applications (MCA): Should have passed recognized Bachelors Degree (BCA / Bachelor's degree in Computer Science Engineering or its equivalent degree / B.Sc/B.Com/B.A) examination of minimum three years duration with at least 50 per cent marks (45 per cent marks in case of reserved categories) in the qualifying examination with Mathematics at 10+2 level or at Graduation level.
 - c) The qualifying degree obtained by Distance Mode Program/ Open Distance Learning (ODL) should have recognition by Joint Committee of UGC, AICTE and DEC/DEB as per UGC Regulations of 2013.
- 5. The candidates appearing for the final year degree examination shall also be eligible to appear for TSICET-2022
- 6. Admission into any college depends on its recognition/affiliation by the Statutory Bodies.
- 7. Qualifying marks in **TSICET-2022** is 25 per cent and no minimum marks are prescribed for SC/ST candidates.

Mere qualifying in the entrance test does not entitle a candidate for admission into MBA/MCA course unless the candidate:

- Appears for Counseling at the notified centres.
- Applies in response to the admission notification issued by the authority concerned (for part-time\ evening \distance mode).
- Satisfies all the eligibility criteria for admission as stipulated by the authority concerned.

SUBMISSION OF ONLINE APPLICATIONS

TSICET-2022 Applications should be submitted through ONLINE mode only. The Registration fee for online submission and late fee, if applicable, may be paid at TS/AP Online Centres in TS and AP, and also through payment gateways (Debit Card/ Credit Card/ Net Banking).

INSTRUCTIONS CONCERNING ENTRANCE TEST

1. Eligibility for appearance at the Integrated Common Entrance Test (TSICET)

- a) Candidate should be an Indian national and should satisfy local/non-local status requirements as laid down in G.O. Ms No. 25, dated: 19.3.2004; G.O.Ms.No.108 dated 30-7-2005; G. O. Ms. No.66, dated 15-7-2011; G.O.Ms. No.5, dated 2-8-2014; G.O.Ms. No.7, dated 5-8-2014; G.O.Ms. No.33 dated 31-12-2014 and its amendments and G.O. Ms. No. 22, dated 27.07.2019 of Higher Education Department of Telangana State and its amendments from time to time.
- b) The candidates other than Indian nationals should satisfy the rules of the Universities concerned.
- c) The candidates seeking admission into
 - i. Master of Business Administration (MBA) course should have passed a bachelor degree of minimum 3 years duration (B.A/ B.Com/ B.Sc/ BBA/ BBM/ BCA/ BE / B. Tech/ B. Pharmacy/ any 3 or 4 year degree except Oriental Languages).
 - ii. **Master of Computer Applications (MCA)** course should have passed BCA / Bachelor's degree in Computer Science Engineering or equivalent degree / B.Sc/B.Com/B.A with mathematics at ten plus two level or at the graduation level.
- d) As per the latest AICTE Approval Process Handbook 2022-23, the eligibility criteria for admission into MBA and MCA course is revised stiuplating 50 per cent maks for unreserved and 45 per cent marks for reserved categories at the qualifying examination. Candidates shall fulfill the eligibility criteria as laid down in relevent GOs at the time of admission.
- e) The qualifying degree obtained under Distance Mode Program/ Open Distance Learning (ODL) should have recognition by Joint Committee of UGC, AICTE and DEC/DEB as per UGC Regulations of 2013.
- f) The candidates who are appearing for the final year degree examination shall also be eligible to appear for TSICET-2022.
- g) Admission into any college depends on its recognition/affiliation by the statutory bodies.
- h) **Qualifying marks in TSICET-2022 is 25 per cent** and no minimum marks are prescribed for SC/ST candidates.

- 7. Any change whatsoever including that of caste/community/status of category and regional centre claimed in the online application form will not be permitted once the form is registered with the Convener. As per G. O. Ms. No. 58 Social Welfare Dept., Govt. of A.P. Dt. 12.5.1998, the candidates claiming admission MBA/MCA this course under reserved quota meant for SC, ST, Differently Abled candidates and BCs are required to produce Integrated Community Certificate and SADAREM certificate (for Differently Abled persons) issued by the competent authority.
- **8. MEDIUM OF TEST:** English only for Section-C and English & Telugu and English & Urdu for Section-A & Section-B parts of the question paper.

9. TSICET RESULTS

- a) **Qualifying Marks for TSICET-2022:** The qualifying percentage of marks in the Entrance Test is **25 per cent** (i.e. 50 marks out of total of 200 marks). However, for candidates belonging to Scheduled Castes and Scheduled Tribes, no minimum qualifying percentage of marks is prescribed.
- b) **Ranking:** Candidates will be given State-wide ranks in the order of merit in the TSICET 2022. For the preparation of merit list, in case more than one student scores the same ranks at TSICET, the tie will be resolved as follows:
 - (i) By considering the marks scored in Section-A
 - (ii) If the tie persists, marks obtained by a student in Section-B will be taken into consideration.
 - (iii) If the tie still persists, the tie will be resolved by taking into account the age of the candidate giving the priority to older candidate.
- c) Rank obtained in TSICET 2022 is valid for admission into MBA/MCA course (full-time / part-time / evening / distance mode/DOL) of all universities in Telangana State for the academic year 2022-2023.
- **10.** The conduct of TSICET-2022 is subject to orders and instructions issued from time to time by the Government of Telangana and Telangana State Council of Higher Education.
- **11.** All disputes arising out of any matter concerning TSICET-2022 shall be subject to the jurisdiction of High Court of Telangana State only. In such disputes, only the Convener, TSICET-2022 and the Secretary, TSCHE, Hyderabad can be impleaded as respondents.
