The Vice-Chancellor has accorded approval for calling applications in the prescribed proformae in quadruplicate from the eligible regular teachers of the Kakatiya University, those who fulfills the eligibility conditions for movement to the next higher level(s) and/or up-gradation/promotion under Career Advancement Scheme (CAS) as per the provisions of UGC (Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) Regulations, 2018, dated 18/07/2018 read with G.O. under reference 2<sup>nd</sup> cited and other relevant guidelines/instructions issued from time to time, as applicable to them:

All the eligible teachers are informed to note the following before submission of their applications to the undersigned:-

- 1. The teachers shall offer themselves for assessment for promotion by submitting an application. In case where CAS promotion is pending for multiple stage(s) of promotion, the teachers are hereby advised to submit separate applications for each stage of CAS promotion and after scrutinizing such applications for lower stage. application for higher stage shall however be considered as per rules.
- 2. The teacher shall be on the rolls and in active service of the University on the date of consideration by Screening-cum-Evaluation Committee for promotion under the CAS.

- 3. The teachers are informed to ensure that all the prescribed conditions have been fulfilled before submission of their applications for the purpose of CAS promotions and that the relevant documents shall only be attached, along with the application form, in respect of the relevant period for consideration to the promotion. In case, if any teacher is willing to submit more than one application form for different stages, the relevant documents for the particular stage shall be attached to the respective application form.

- 5. The teachers fulfilling the eligibility criteria as per the UGC-CAS Regulations issued from time to time are required to submit their applications to the Assistant Registrar, Administration Branch (Teaching & Gazetted), Kakatiya University, Warangal, along with relevant documents in four (4) sets, on or before 12<sup>th</sup> August, 2022.
- The teachers whose applications submitted in response to this office circulars issued in 2019 and 2020 are required to apply afresh in response to this circular accordingly.
- 7. It may please be noted that incomplete applications and/or applications received after the last date will not be entertained.
