## **Theme of the Seminar:**

Historically the tribals have been one of the most exploited and deprived sections of the population in Indian Society. A large section of the tribal communities which came under colonial rule in different phases lived in different isolation from the rest of the Indian society. They have distinct culture, social practices and they have been subject to massive exploitation and discrimination. Their life is integrated to local ecology and forests. Most of the tribals remain at the lowest stratum of the society due to various factors like low level of literacy, education, health, primitive occupations and extreme levels of poverty, lack of control over resources and political participation.

Therefore, the proposed National Seminar will focus on the following crucial issues which determine the Socioeconomic conditions prevailing in tribal communities.
