Sub: Establishment – Temporary Teaching Arrangements – Assignment of left-over teaching work-load on Paper-wise remuneration basis to the new eligible candidates for the odd semesters of the academic year 2025-2026 – Regarding.

Sir / Madam,

In view of left-over work-load in certain departments during the last academic year 2024-2025, due to non-receipt of permission from the State Government and in pursuance of the decision of the Standing Committee of the Academic Senate at its 4th meeting held on 22/03/2025, the Hon'ble Vice-Chancellor has accorded permission to arrange temporary teaching on paper-wise remuneration basis, i.e., Rs.20,000/- per theory paper and Rs.10,000/- per practical paper against the actual left-over work-load for completing the syllabus of even semesters of the academic year 2024-2025 only, vide ref.1 cited. Accordingly, temporary teaching arrangements were made on paper-wise remuneration basis. However, the permission of the State Government is not yet received.

In view of the above and on the request of certain Heads of the Departments, KU and in anticipation of the approval of the Executive Council, the Vice-Chancellor has accorded permission to all the Heads of the Departments, KU, to make temporary teaching arrangements to the eligible candidates on paper-wise remuneration basis, i.e., Rs.20,000/- per theory paper and Rs.10,000/- per practical paper against actual left-over work-load for completing the syllabus of odd semesters of the current academic year 2025-2026 only for the benefit of students, subject to the following:

- (i) To follow the procedure as stipulated earlier in this regard.
- (ii) Not to assign additional teaching work-load to any existing regular/contract/part-time or retired teachers on paper-wise remuneration basis.
- (iii) Assign full paper to only one candidate, unless there is any partial paper un-assigned after assignment of total teaching work-load.
- (iv) This assignment is purely temporary (a stop gap arrangement) and does not confer any rights for absorption in to the university as either part-time / contract or regular basis.
- (v) Continuing of existing candidates is at your discretion only, subject to their performance and conduct.
