 - b) The staff appointed on the project should be paid as indicated in the budget statement attached.
 - c) The approved duration of the scheme is for 3 Years. The annual extension will be given after review of the work done on the scheme during the previous year.
 - d) Two copies of the annual progress report (with soft copy also) of work done be submitted to the Council every year after completion of ten months of the project, failure of submit the report in time may lead to termination of the project.

- e) The institute will maintain a separate account of the receipts and the expenditure incurred on the scheme and will furnish a utilization certificate and an audited statement of accounts pertaining to the grant.
- f) The next year grant will only be released after receipt of the Progress Report along with Utilization Certificate and Statement of Expenditure.
- g) The other terms and conditions are indicated in Annexure I. The receipt of this letter may please be acknowledged.
