Sir/Madam,

I draw your attention to the Govt. Circulars under reference cited wherein operational guidelines were issued for implementation of Telangana Haritha Haaram programme launched by Hon'ble Chief Minister Shri Kalvakuntla Chandrashekar Rao on 3 July 2015. It is one of the Telangana Flagship programmes to rejuvenate degraded forests. In the areas outside the existing forest, massive planting activities were to be taken up in areas such as; road-side avenues, institutional premises, The National Forest Policy of India envisages a minimum of 33% of the total geographical area under forest cover to maintain environmental stability and ecological balance

On this context I am to inform you that the Vice-Chancellor has desired to take up this Haritha Haaram Program on priority by planting more saplings in the premises of all the affiliated colleges (University/Constituent/Autonomous/ Aided/Unaided/Priate) under the jurisdiction of kakatiya University for two weeks from 24^{th} July to 7^{th} August 2022.

Hence you are hereby informed to take up the programs by planting neem, kanuga, neredu, maredu, rela, gulmohar, raintree, badam and peltophorum wherever required in the premises of your college for the said two weeks by involving the staff and students. The Colleges have to take measures for Protection and regular watering to the saplings in the entire premises. The Action taken report may be submitted to the Academic, Kakatiya University for the record.
