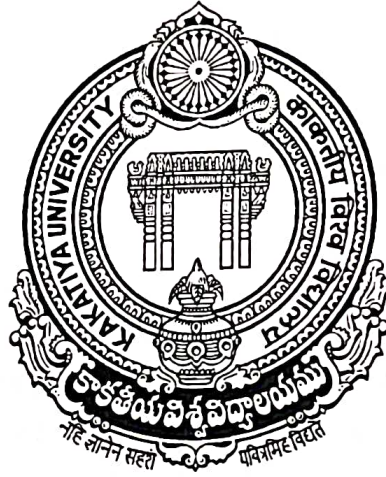

## Rules and regulations of B.Ed. (ODL) Course

SDLCE, Kakatiya University, Warangal

With effect from the academic year 2018-2019

### 1. Preamble

The Bachelor of Education (B.Ed.) in ODL mode is a professional course for in-service teachers, a second degree in teacher education, primarily intended for upgrading the professional competence of working teachers have entered the profession without formal secondary teacher training. It aims at preparing in-service teachers for the secondary state of education.

### 2. Duration

The duration of B.Ed. ODL course shall be Two years (face to face programme in two summer vacations). However the students shall be permitted to completed the course within a maximum of five years as per NCTE regulations.

### 3. Intake

The sanctioned intake for the B.Ed. ODL is 500 students. There shall be 10 students' learner centres. Each study centre shall enroll 50 students in a given academic year.

### 4. Eligibility

The following candidates are eligible to pursue B.Ed. (ODL):


- i. Trained in-service teachers in elementary education.
- ii. Candidate who has completed a NCTE recognized teacher education program through face- to-face mode.
- iii. Candidate should be a Graduate –B.A./B.Sc./B.Com.
- iv. All the reservation and relaxation as per university Distance Education rules.

### 5. Admission

A candidate for admission to two year B.Ed. (OLD) course has to qualify at the entrance test conducted by the SDLCE K.U for the concerned academic year. The candidates will be admitted strictly in accordance with the merit secured at the entrance examinations, keeping in view the rules and regulations in force in respect of the statutory reservation of seats under various categories of candidates as per the NCTE guidelines and Telangana state and university rules in vogue. Admission shall be methodology wise as per G.O. No. 13, dated 27-05-2017.


The candidate has to pay a fee of Rs.25, 000 at the time of joining and Rs.10,000 in the second year.

7. Curriculum  
The curriculum offered at B.Ed. (ODL) shall be on par with B.Ed. face-to-face mode. The syllabus of face to-face mode shall be transformed into distance mode consisting of blocks/ units as per credit hours of study. However, all those modalities shall be taken care of the material preparation. Course is in blended mode. The self learning course material be modular and credit based. Self instruction material will be made available.

7.1 Contact program  
Apart from the school based activities and practice teaching in a course of two years duration, the personal contact program shall cover consoling and workshop, seminar presentation, tutorials, report writing, etc. shall be held at headquarters or study centers convenient to the learners for a period of one month (in each summer).

- a) Academic Counseling: 60 days spread over two years are devoted to counseling sessions. The counseling sessions are in the form of tutorials and not as teaching sessions as the learning materials provided shall perform the teaching function. The academic and personal problems related to the course shall be discussed in the counseling sessions. The counseling difficulty, filed work, teaching practice, projects, assignments, time management, study hours spread over two years. The detailed schedule will be provided after admission.
- b) Workshop: Micro-teaching, Reflective-teaching, and four EPCs will be conducted during workshops. Lesson planning, technology integrated lessons, art and craft integrated sessions. Innovative pedagogy lessons, preparation of teaching aids, CCE, all required practice sessions. Every year there shall be two workshops of six (6) days duration.
- c) School-based activities: the teacher should involve in all activities which a teacher is supposed to perform in a school. The mentor (a Lecture / Academic Counselor of Study Center) shall observe for a minimum of 15 study hours. Learners can interact with a experienced senior member of the faculty.
- d) Teaching practice: A learner enroll in B.Ed. program through the ODL system shall go through the teaching practice for six weeks (teaching practice 5 days at the study centre and 25 days internship at the nearest school in each year) in the schools where he/she under the supervision of senior teacher/ academic counselor. Each lesson will be guided, supervised, assessed and feedback will be given. The

learner shall be provided constructive feedback on his/her performance (strengths and weaknesses) by the supervisor/teacher educator.

- e) There shall be students assignments, 30% weightage be given to assessment of assignments. At the end of first and second years the external examination will be conducted by the controller of Examination, Kakatiya University. Study center located in the teacher education institutions shall conduct examinations of practice teaching and work experience components as per the university guidelines.

**Program organization:** SDLCE website shall provide all the information required to the learners from time to time. Also the resources and other facilities shall be made available on website. It provides all the information related to the candidates, enrollment, study centers, examinations, schedule of activities, etc.

8. **Examination:** Two-tier evaluation shall be used by the university. Continuous and Comprehensive Evaluation (CCE) and Term-End Examination shall be conducted as per the scheme of examination. The weightage for internal and external examinations shall be in ratio of 30:70.

**Monitoring and Supervision:** Regular field visits by the faculty, Feedback from the study center coordination and also interaction with learners through ICT shall be arranged.







The above shall be implemented as per NCTE norms, 2014 referred in the document under sections 5.1 Academic faculty; 5.2 Qualifications; 5.3 Administrative and professional staff; 6.1 Infrastructure; 6.2 Instructional and 6.3 other amenities.

#### 10. Selection of Methods of Teaching


- i. Every candidate is expected to select two methods of teaching under B.Ed. Course. The method-I shall be based on the subject the candidate has studied in Degree (eligibility) course and also to appear in that subject in the entrance examination.
- ii. Method-II also shall be based on the subject that the candidate studied in Degree (eligibility) course and will be allotted by the institute where the candidate is seeking admission., the selection of subject shall be based on their Intermediate (+2) study as per Ed.CET norms. In case of English Method-I, selection of second method shall be based on the subject pursued at the Intermediate level. In case of Graduates, Mathematics and Physical Science are offered as Methodology subjects.


#### Note:

- i. No candidate is allowed to select two language methods.
- ii. Candidate may select one Language and one Non-language method of teaching or she / he may select any two Non-language methods under the course.

#### 11. General Rules for Examination

- i. All Examinations of the University shall be held at University jurisdiction or Headquarters of the University or at such places and on such dates as may be notified.
- ii. Students who have appeared once at any examination of the university need not put in fresh attendance if they want to re-appear for the same examination notwithstanding the fact that new subjects may have been introduced or the group of subjects has been changed by the university. They will, however, have to appear at the examination according to the scheme of examination and the syllabus in force.
- iii. Whenever a course or a scheme of examination in K.U. changes, one more examination in the following year shall be conducted according to the old syllabus/regulations. Candidates not availing themselves of this one chance or failing at this examination shall take the examination thereafter according to the changed syllabus and regulations.

- iv. Candidates will be allotted to B.Ed. (ODL) course at the time of admission, strictly depending on the merit secured at the common entrance test and subject to the rules and regulations in force from time to time, including rules of reservation.
- v. The University examination in theory papers shall be in the form of written examination. Besides the written examination, there will be practical examinations in the two methods of teaching opted by the candidate. Practicum is examined by two jury members (one internal and one external examiner) which will be conducted as per the schedule notified by the Controller of Examinations, KU.

## 12. Rules of Attendance & Re-admission:

### A. Attendance:


1. The degree of Bachelor of Education shall be conferred on a candidate who, after getting admission into the B.Ed. (ODL) course as specified above, has pursued a "Distance Mode Course of Study" as herein prescribed and fulfilled the conditions laid down for the attendance of students and passed the prescribed teaching examination both in theory and practical.
2. A Distance Mode course of study in Kakatiya University means attendance not less than 80% in teaching / instructional period and 90% of attendance during the period of practical / internship of the B.Ed. (ODL) programme. In special cases, the Vice-Chancellor may condone deficiency of attendance not exceeding 10% on the recommendation of the Principal, College of Education and Director, SDLCE, K U based on medical certificate by an authorized Medical Officer under Government service not below the rank of a Physician.
4. Bio-metric attendance for in service teacher's trainees and Councilors is compulsory from the academic year 2018-19 for the Students Learner Centres.

## 13. Re-Admission:

The students who fail to maintain 40% to 70% of attendance are not eligible for seeking readmission as per KU rules in vogue.

- Grade Point** is weightage allotted to each grade letter depending on the marks awarded in a course/paper.
- Credit Points** number of credits assigned for the paper multiplied by grade point secured for that course / paper.

## 15. Microteaching, Reflective Teaching and Internship

- i. The candidates are expected to complete 2 microteaching lessons (choosing any two from different microteaching skills) in each Method before going for Internship.
- ii. The candidates are expected to take two period plans for duration of 20 minutes for their peer group as a part of their Reflective Teaching.
- iii. The candidates are expected to observe the demonstration lessons undertaken by the Faculty of the college in the school.
- iv. In First year every candidate shall have to undergo an internship of 6 weeks (30 working days) in a cooperating school as "Intern". During this period, the candidate shall be attached to a school (within a radius of 5 KM from their working place) and he/she shall have to undertake duties & responsibilities on par with regular school teacher in all the school activities. During this period, the candidate shall teach 20 period plans covering 20 period plans from each of the methodology subject respectively (20 +20) in the school, under the supervision of the trained subject teachers in the school who are referred to here as "Supervising Teachers". A Certificate of satisfactory work by the Head Master of the cooperating school shall be a pre-requisite for the candidate to appear for the final practical examination.
- v. The teaching staff of the study centre will give demonstration lessons in the concerned methodology subjects at the cooperating schools as and when necessary, in addition to the demonstration lessons given at the beginning of Internship, for the guidance of student-teachers.
- vi. In case, Internship is not completed, the candidate shall appear for the subsequent examinations in the Final Practical Examination only after completing the Internship by seeking fresh admission to B.Ed.(ODL) in this regard and producing thereafter, certificates of completion of internship.
- vii. The final practical examination of each candidate will be conducted by two examiners -one internal and one external.
- viii. Internship is of 6 weeks (30 days) duration at their work place. During the Second year the candidate shall be attached to a school (within a radius of 5 KM from their working place) and he/she shall have to undertake duties & responsibilities on par with regular school teacher in all the school activities. During this period, the candidate shall teach 20 period plans covering 20 period plans from each of the methodology subject respectively (20 +20) in the school, under the supervision of the trained subject teachers in the school who are referred to here as "Supervising Teachers". A Certificate of satisfactory work by the Head Master of the cooperating school shall be a pre-requisite for the candidate to appear for the final practical examination.
- ix. All the records shall be written strictly by the candidates in their own handwriting.

**16. Pattern of Theory Question Papers**


There are two Patterns of Theory Examinations – one with a duration of 3 hours for 70 marks; the other with a duration of 1 ½ hours for 35 marks. The question paper comprises two sections:


In 70 marks paper, Section A – consists of 8 very short answer type questions out of which a candidate is expected to answer any five questions. Each question carries 4 Marks. Total marks for Section – A is 20 marks. Section B – consists of eight essay type of questions, out of which a candidate is expected to answer any five questions in about four pages each. Each question carries 10 Marks. Total marks for Section – B is 50 marks.

Similarly, for 35 marks paper, Section A – consists of 5 very short answer type questions, out of which a candidate is expected to answer any three questions. Each question carries 5 Marks. Total marks for Section – A is 15 marks. Section B – consists of Four Essay type of questions, out of which a candidate is expected to answer any two questions in about four pages each. Each question carries 10 Marks. Total marks for Section – B is 20 marks.

**17. Conduct of Practicum Examinations**

Each of the Practicum papers (EPCs) has examinations for 35 marks each and final practical examination (final lesson) for 50 marks. Details of the conduct of examination are given in respective papers.
