In the reference 1st cited the registrars of universities in Telangana are requested to depute the faculty members and Professors of relevant Social sciences departments to attend workshop for planning for executing evaluation studies and ethnographic studies that are proposed to be conducted under the scheme Grants to TRIs sanctioned by the Ministry of Tribal Affairs, Government of India.

Further it is requested to ensure that the qualified research personnel shall be engaged separately for each approved project without duplication of staff and ensure that the assignment would be completed in 100 days period from the day of release of 1st installment of the sanctioned amount for the projects. Further with respect to the funding, the grant will be released in 4 installments upon the progress of the research project as under

50% of sanctioned amount	After unequivocal acceptance of letter of award
20% of sanctioned amount	After completion of data collection and submission of interim report
20% of sanctioned amount	After submission of Draft Report
10% of sanctioned amount	After submission of final report
