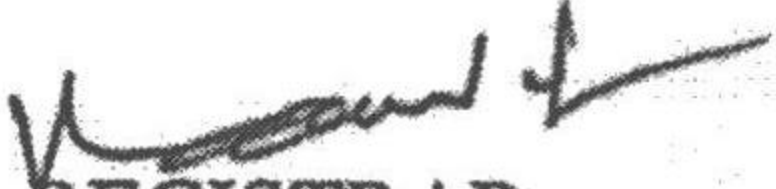
Sir/Madam,

You are aware that the process of making admissions into I-Year all B. Pharmacy / M. Pharmacy. / Pharm. D. Courses for the academic year 2025-2026 is in progress. As per the procedure, the Colleges have to get the approval for the admissions made under Management and Minority Quota from the TSCHE, Hyderabad and Minority Welfare Department, Govt. of Telangana.
