Sub: Establishment – Allowances – Dearness Allowance – Enhancement of Dearness Allowance to the University Teaching and Non-teaching employees, including Time-Scale Employees, with effect from **01/01/2017** – Sanction – Orders – Issued.

The State Government has issued orders vide G.O. 3<sup>rd</sup> cited, revising the rate(s) of Dearness Relief sanctioned under reference 1<sup>st</sup> cited and implemented by the University vide reference 2<sup>nd</sup> cited, to the State Government employees including teaching and non-teaching employees of the Universities in the State with effect from **1<sup>st</sup> January, 2017**, subject to the conditions as prescribed in the above said orders. The details of revision of Dearness Allowance are as follows:

Non-Teaching Staff (under R.P.S.-2015) from **22.008%** to **24.104 % (2.096%)**  
Non-Teaching Staff (under R.P.S.-2010) from **99.296%** to **102.72% (3.424%)**  
Teaching Staff (U.G.C. Pay Scales-2006) from **132 %** to **136 % (4%)**

Based on the G.O. 3<sup>rd</sup> cited, the Vice-Chancellor has accorded approval for implementation of the above said revised rates of Dearness Allowance to the teaching and non-teaching employees, including Time-Scale Employees of the Kakatiya University as per the terms and conditions as stipulated by the State Government from time to time in this regard.

All the Drawing Officers, K.U., are requested to take necessary action as per the provisions of the G.O. 3<sup>rd</sup> cited above and prefer the claims for payment of D.A. of the employees concerned accordingly.

Further, the component of arrears on account of the implementation of the said G.O. 3<sup>rd</sup> cited, Dearness Allowance shall be paid in cash with the salary of **September, 2017** payable on or after **1<sup>st</sup> October, 2017**. The arrears on account of payment of Dearness Allowance for the period **from 01/01/2017 to 31/08/2017** shall be credited to the GPF Account of the respective employees, only after the release of the grant(s) by the State Government. In respective of Full Time Contingency/ Time-Scale Employees the arrears may be paid in cash with the salary for the month of **November, 2017** payable on **1<sup>st</sup> December, 2017**.

The Audit Officer (Pre-Audit), KU, shall ensure that the terms and conditions prescribed in the G.O. 3<sup>rd</sup> cited above are scrupulously followed by the Drawing Officers while claiming the amount in this regard.

The Revised Dearness Relief shall be paid along with the pension of **September, 2017** payable on **25.09.2017**. However, the arrears of revised Dearness Relief to the Pensioners from **01.01.2017 to 31.08.2017** shall be paid along with the pension of **November, 2017 payable on 1<sup>st</sup> December, 2017**.

All the Drawing Officers, K.U., are requested to take necessary action as per the provisions of the G.O. 3<sup>rd</sup> cited above and prefer the claims for payment of D.A. of the employees concerned accordingly.
