Sub: Establishment – University Teachers – UGC RSP – 2006 - **Career Advancement Scheme** – Applications for award of next higher grade (AGP), Promotion of Associate Professor/Professor – Called for – Circular – Issued.

It is proposed to consider the promotion/award of next higher grade of the University teachers, whose **eligibility falls on or before 22/05 /2019**, under Career Advancement Scheme in terms of the Govt. - 2) **Assistant Professor Rs.15600-39100 + AGP Rs. 8,000/-**
- 3) **Associate Professor Rs.37400-67000 + AGP Rs. 9,000/-**
- 4) **Professor Rs.37400-67000 + AGP Rs.10,000/-**

The University will not process the applications of those who do not fulfil the required eligibility criteria as prescribed in various Govt. Orders/UGC guidelines/clarifications issued for the purpose from time to time. No correspondence will be entertained in this matter.
