Sub:- Establishment – Contributory Pension Scheme – Extension of benefits of ‘Retirement Gratuity and Death Gratuity’ – Adopting the GO & Circular Memo for implementation to the employees of the University who were appointed on or after 1/9/2004 – Orders – Issued.

The Government of Telangana has issued the GO and Circular Memo vide references 1st and 2nd cited extending the benefits of Retirement Gratuity and Death Gratuity to the State Government Employees covered by Contributory Pension Scheme (NPS). The KU Non-Gazetted Officer’s Association has submitted a letter vide reference 3rd cited for adoption and implementation of the Government Order and Circular Memo to the University employees those who are covered by the Contributory Pension Scheme / SBI-Life with effect from 1/9/20014 onwards.

The aforesaid proposal was placed before the 96th Finance Committee (Agenda Item 96.01) held on March 19, 2019, which resolved to approve and recommend to the Executive Council for approval, KU. The Executive Council in its 127th meeting (Agenda Item 127.09) held on 1/6/2019 has resolved to adopt the G.O. and Circular Memo extending the benefits of ‘Retirement Gratuity and Death Gratuity’ to the State Government employees covered by Contributory Pension Scheme (NPS).

In pursuance of the resolutions taken by the Finance Committee and Executive Council in their respective meetings, the Vice-Chancellor has accorded approval for adopting the G.O. Ms. No. 60 Finance (HRM.V) Department, dated 23/5/2018 and Circular Memo No. 1149/223/A2/2016 dated 6/7/2018 for implementation to the Employees of the University who were appointed on or after 1/9/2004.

Consequent to the implementation of these orders, the relevant Statutes, Ordinances, Regulations, etc. in vogue of the University shall be deemed to have been amended forthwith.
