Based on the recommendations of the X Pay Revision Commission, 2015, the State Government has issued G.O. under reference 3rd cited for enhancement of the reimbursement of tuition fee from Rs.1,000/- to Rs.2,500/- per annum, per pupil, to the children, not exceeding two, of all the Non-Gazetted Officers and Class-IV employees studying in all the classes from LKG, and upto Intermediate/12th Class, subject to the other usual conditions regarding the submission of receipts, certificate, etc., as per existing Rules and Regulations, from the academic year 2015-2016.

After careful examination and in anticipation of the Finance Committee and Executive Council, the Vice-Chancellor has accorded approval for adoption and implementation of the above Government Order vide reference 3rd cited, mutatis mutandis, for the benefit of the Non-Gazetted Officers and Class-IV employees working in the Kakatiya University, Warangal with immediate effect.

The expenditure on the above score shall be met from the provision of "0902-Educational" Concession to Staff" provided under the Head of "09-Grants & Subscriptions-Others" in the Part I: Non Plan Budget – Revenue Account – Charges.
