**ANNEXURE**

Given below is the proposed detailed plan of how we can engage the educational institutions across the state.

1. All High Schools and Colleges in the District, **through DEOs/MEOs**, may be instructed by **DLSAs/MLSAs** and by District Collectors to do Anti-Drugs programs in their respective or nearby locations. The programs could comprise of one or more of the following:
  - a. Anti Drugs Rally
  - b. Human Chain Formation
  - c. Oath taking by Students
  - d. Meditation by Students
  - e. Competitions on the subject of Drug abuse – Elocution/Essay Writing/Painting/Debates/Stage performance
  - f. Anti Drug & Empowerment Committees formation
2. **District wise WhatsApp groups** may be created with members from Education dept, Principals/Coordinators of Schools & colleges in district, DLSA/MLSA members, District Collectorate members and Dharma Seva members.
3. All Industries in the District, through Industries Dept, may be instructed to do Anti-Drugs programs. District wise WhatsApp groups may be created with members of Industries dept, Industrial associations, Industry management, HRs and Dharma Seva members.
4. All stakeholders who are organizers shall attend “How the Dheerah Anti Drugs program will be organized” Webinar on **June 14, 2025** – 10am-11am.
5. Dharma Seva will be conducting Webinars (online) to create awareness to Educational institutions on the Drugs issue and the Roadmap to achieve the solution. Webinars will also provide necessary info on how to do Anti Drugs Rallies/Human chain/Oath/Competitions. Webinars may be attended by the DLSA officials, DEOs/MEOs and Management/concerned teachers and students, Management of Industries on one of the below days as per their convenience:
  - a. **June 14, 2025 – 10am-11am – Webinar to DLSAs, MLSAs, organizers**
  - b. **June 19, 2025 – 10am-11am – Telugu**
  - c. **June 20, 2025 – 10am-11am – English**
  - d. **June 21, 2025 – 10am-11am – English**
  - e. **June 23, 2025 – 10am-11am – Telugu**
  - f. **June 24, 2025 – 10am-11am – English**
  - g. **June 25, 2025 – 10am-11am – English**

6. Before the Anti Drugs rallies/other programs, a motivational message will be given to all participants by TSLSA, Dharma seva and other stakeholders on:
  - a. June 26, 2025 – 10am-10:30am – Anti Drugs message for Schools
  - b. June 27, 2025 – 10am-10:30am – Anti Drugs message for Colleges
  - c. June 28, 2025 – 10am-10:30am – Anti Drugs message for IndustriesFollowing the message, the respective institutions shall conduct their Anti-Drugs programs.

13. Educational institutions / Industries shall form Wellness and Empowerment committees
14. Students / Staff members shall take part in Wellness / Empowerment activities on daily basis. They can download Dheerah App and sign up for free online Wellness classes.

15. Educational institutions shall implement the operational guidelines for Prahari (Anti drugs) clubs issued vide GO MS No. 22 Dated 20.09.2024 (copy enclosed). Dheerah (Prahari) App may be used to by Educational institutions for the purpose.
