KAKATIYA UNIVERSITY - Revised Scales of Pay-2020 to the Regular Non-Teaching Staff with effect from notionally 01-07-2018, monetary benefit from 01-04-2020, and salary from the month of June, 2021 payable in July, 2021 -Sanction for implementation of – Orders – Issued.

The State Government have communicated its sanction orders for implementation of Revised Scales of Pay-2020 to the non-teaching employees of the Universities in State of Telangana, with effect from notionally 01-07-2018, monetary benefit from 01-04-2020, and salary from the month of June, 2021 payable in July, 2021, vide G.O. cited under the reference. Accordingly, the following GOs were submitted for the approval of 100th Finance Committee held on 18-11-2021 under agenda item 100.01, which approved and recommended to the Executive Council for approval. The Executive Council in its 136th meeting held on 18-11-2021 under agenda item 136.02 has resolved to approve the Finance Committee recommendations for adoption and implementation of G.O.Ms.No.93, Finance (HRM-IV) Department, dated 24/08/2021 and other related GOs of DA, HRA, CCA etc., issued from time to time.

In pursuance of the decision taken by the Finance Committee and Executive Council in their respective meetings, the Vice-Chancellor has accorded approval for adoption of the following G.Os of RPS-2020 issued from time to time by the State Government, mutatis mutandis with immediate effect and sanction for implementation of the Revised Scales of Pay-2020 to the regular non-teaching employees of this University with effect from notionally 01-07-2018, monetary benefit from 01-04-2020, and salary from the month of June, 2021 payable in July, 2021, as per the terms and conditions as stipulated by the State Government in the following Government Orders:

All the regular non-teaching staff members who are drawing Revised Pay Scales-2015 are requested to exercise their option as per the principles laid down by the State Government, vide G.O.Ms.No.93 Finance (HRM-IV) Department, Dated 24-08-2021, and submit the same in quadruplicate to the Audit Officer (Pre-Audit), Kakatiya University, Warangal, for drawing the pay in the Revised Scales of Pay 2020 or to remain in the existing pay scales with in a period of three (3) months from the date of issue of these orders. In case, no option is exercised within the stipulated period, it will be deemed that employee(s) has/have opted for Revised Scales of Pay-2020 with effect from 01-07-2018. The option once exercised shall be final.

All the Drawing Officers concerned are requested to see that the employees concerned should exercise the option in terms of the above cited GOs and to follow the instructions scrupulously. Further, the Drawing Officers shall prepare the Pay Fixation Statements accordingly in the prescribed Proforma appended to the above said G.Os, and get them approved by both the Audit Officer (Pre-Audit) and the District Audit Officer of the State Audit Department, KU, Warangal, for fixing the Pay in the Revised Scales of Pay-2020.

Further, the arrears of pay payable on account of implementation of the Revised Pay Scales-2020 shall be as follows:

Part I: From 01-07-2018 to 31-03-2020 for which the fixation is notional.

- Part-II: From 01-04-2020 to 31-03-2021, for which arrears of pay fixation in the RPS, 2020, shall be paid at the time of superannuation of the Government employee or to the legal heirs in case of demise of the employee.
 - Part-III: From 01-04-2021 to 31-05-2021 for which period, the arrears will be paid during the financial year 2021-22
 - Part-IV: From 01-06-2021 onwards to the date of fixation of pay in the RPS, 2020 the salary for which period will be paid from the month of June, 2021 payable from 1st July, 2021 onwards

Consequent to the implementation of these orders, the relevant Statutes, Ordinances, Regulations, etc., in vogue of the University shall be deemed to have been amended forthwith.
