Sub: PENSIONS – Dearness Relief to the KU Pensioners – Enhancement of Dearness Relief to the Pensioners (Teaching & Non-teaching) on par with the Government Pensioners – Adoption of G.O.Ms.No.4, Finance (HRM-V) Department, dated 19/01/2022, in respect of pensioners of RPS-2015, RPS-2020 & Revised UGC Scales of 2006 & 2016 with effect from **01/07/2021** – Orders = Issued.

The State Government has issued orders vide G.O. 3rd cited, revising the rate(s) of Dearness Relief sanctioned under reference 1st cited and implemented by the University vide reference 2nd cited, to the State Government Pensioners including Pensioners (Teaching & Non-teaching) of the Universities in the State with effect from **1st July, 2021**, subject to the conditions as prescribed in the above said orders. This increase subsumes the installments of Dearness Relief arising on 01/01/2020, 01/07/2020 and 01/01/2021. The Dearness Relief for the period from 01/01/2020 to 30/06/2021 shall remain at 7.28%; 38.776%; 17% and 164% only. The details of revision of Dearness Relief are as follows:

The Revised Dearness Relief shall be paid along with the pension of **January, 2022** payable in the month of **February, 2022**. However, the arrears of revised Dearness Relief to the Pensioners from **01/07/2021 to 31/12/2021** shall be paid in **Six (06) equated monthly installments starting from April, 2022, Payable in the month of May, 2022**.

All the Drawing & Disbursing Officers, K.U., are requested to take necessary action as per the provisions of the G.O. 3rd cited above and prefer the claims for payment of Dearness Relief of the Pension concerned accordingly.

The Audit Officer (Pre-Audit), K.U, shall ensure that the terms and conditions prescribed in the G.O. 3rd cited above are scrupulously followed by the Drawing Officers while claiming the amount in this regard.
