The Service Associations, Kakatiya University, Hanamkonda have submitted a joint representation vide reference 2nd cited, to accord permission for Surrender of Earned Leaves for encashment to all the eligible employees during this Calender Year 2022.

After careful examination, the Vice-Chancellor has accorded administrative approval for the payment against the surrender of 'Earned Leave for Encashment' as per rules in vogue of the University for the Calendar Year 2022, in a phased manner, by the Non-teaching Employees (Gazetted Officers, Non-Gazetted Officers & Class-IV Employees) of the Kakatiya University, Hanamkonda for encashment for 15 / 30 days from 01/04/2022 to 15/04/2022 / 01/04/2022 to 30/04/2022 as the case may be, for eligible employees:

All the Drawing Officers/Principals concerned are requested to claim the surrender of Earned Leave for encashment in respect of the employees working under their control for the Calendar Year 2022 and the bills shall be submitted to the Audit Officer (Pre-Audit), KU, for passing and recording of the claims in respect of the surrender of earned leaves.

The expenditure on the above score shall be met from the provision of "Administrative Staff – Pay & Allowances" provided under the Head of "Administrative Staff Salaries" of Part-I Non-Plan Budget – Revenue Account – Charges for the financial year 2022-23.

However, all the Principals/Director, SDLCE, KU etc., are hereby requested to make arrangements for payment against surrender of Earned Leave for Encashment to the eligible employees working under their control from out of the available funds. The payment made by the Principals on this score will be treated as refundable advance and the same will be refunded soon after the receipt of the Grant-in-Aid from the State Government.
