Sub:- Establishment-Temporary Teaching Arrangements – Revision/Enhancement of remuneration to the Contract / Part-time teachers of Self-finance Courses of University Colleges from the academic year 2021-2022, i.e. w.e.f. 01/09/2021 onwards in terms of G.O.Rt.No.141, H.E. (UE) Dept., dated 01/09/2021 as per the provisions of G.O.Ms.No.11, dated 18/04/2018 – Permission for payment of the enhanced remuneration to the contract / part-time teachers for the work-done period beyond 01/09/2021 for the academic year 2020-2021 due to COVID-19 pandemic - Orders – Issued.

While adopting G.O.Rt.No.141, Higher Education (UE) Department dated 01/09/2021 for extending the revised remuneration as per the provisions of G.O.Ms.No.11, Higher Education (UE) Department, dated 18/04/2018 to the Contract / Part-time teaching faculty of Self Finance Courses and others in Kakatiya University from the academic year 2021-2022, administrative sanction orders under reference 4th cited have been issued for implementation with effect from 01/09/2021 onwards. However, in the case of PG and other professional courses, the duration of academic year 2020-2021 had been prolonged beyond 01/09/2021 due to COVID-19 pandemic situation, and hence, the contract / part-time teachers had to work without enhancement / revision of their respective remunerations as per KU Orders 4th cited.

Now, after careful examination of the representation under reference 5th cited and after bringing it to the notice of the Executive Council at its 137th meeting held on 26/03/2022, the Vice-Chancellor has accorded permission to approve / ratify the enhanced payment of remuneration to the contract / part-time teachers, whose remuneration has been revised for enhancement during the academic year 2021-2022, for the work-done period beyond 01/09/2021 for the academic year 2020-2021, subject to other terms and conditions set for the purpose.
