Attention of all the Drawing and Disbursing Officers (DDOs) in the Telangana State is invited to the subject cited and informed that it was observed that at present some of the DDOs in the State are furnishing TDS GSTIN (GSTIN with 14<sup>th</sup> digit as 'D') while procuring any goods or services as a result of which the suppliers are declaring the transactions as B2B transactions in their GSTR1 and GSTR 3B returns due to which there is loss of revenue to the State through IGST settlement mechanism.

Therefore, it is hereby informed that all the DDOs in the State shall exercise caution while declaring the GSTIN with the suppliers. **"The DDOs are advised not to issue TDS GSTIN's to their suppliers and should issue normal GSTIN's only when it is absolutely necessary. In case the credit of tax is not claimed by the Government Department, the supplier may be asked to declare the supply as B2C transactions"**.
