Sir/Madam,

I am to inform you all that the State Government have taken several initiatives in Higher Education Institutions for enhancing Access, Quality and Equity. To reinforce the Quality, the State Government made Aadhaar Enabled Biometric Attendance System (AEBAS) mandatory for students and staff of all the educational institutions. This requirement is important for calculating the attendance for the purpose of e-pass scholarship/fee reimbursement, etc., in the case of students and for calculating the duty period of the staff, both teaching and non-teaching and also for calculating their leaves and issue instructions accordingly to the concerned by the competent authorities.

As per the earlier procedure followed by this university before the lock-down of establishments due to prevalence of COVID-19, the universities are now informed to take action for implementation of "Biometric Attendance/AEBAS" in all the colleges, departments and offices under their jurisdiction for students and staff (teaching and non-teaching) from the academic year 2022-2023 for the above said purposes.

In the light of the above said instructions, I am to inform you that the Vice-Chancellor has accorded approval for resumption of "Biometric Attendance/AEBAS" in all the colleges and offices under the jurisdiction of the Kakatiya University, Warangal, with effect from 01/12/2022 with the technical support and maintenance mechanism of M/s.Telangana State Technology Services Ltd., Hyderabad as per the administrative sanction orders issued by this university, vide orders 3rd cited and subsequent correspondence with them from time to time.

Therefore, you are informed to send the confirmation to the university immediately with regard to the Aadhaar Enabled Biometric Attendance System (AEBAS) and also keep the data ready for sending it to the university regularly for authentication and necessary utilization by the authorities concerned.

The expenditure on the above score shall be met from out of the receipts of enhanced examination fee, i.e., @ Rs.100/- being collected from the students by the Examination Branch, as per the instructions of the university through this office letter under reference 2nd cited.
