
Vide memo cited under reference 1, the State Government has instructed all the Higher Educational institutions viz., Government, Private Aided and Private Unaided Colleges for mandatory implementation of Aadhar enabled Biometric Attendance System (AEBAS) for the students as well as staff for calculating the attendance across the state as required for promoting the students to the higher classes and also for the purpose of their e-pass Scholarship / Fee reimbursement etc.

Accordingly, this Office vide letters 2<sup>nd</sup> to 4<sup>th</sup> cited, you were informed to take necessary action for implementation of Biometric Attendance for Students and Staff, which is mandatory for promoting the students to the higher classes and also for the purpose of their e-pass Scholarship / Fee reimbursement etc., and to calculate the leaves of both the teaching and non-teaching staff, and to resumption of “**Biometric Attendance/AEBAS**” in all the Colleges with effect from 01/12/2022.

But, it is observed that most of the colleges are not implementing the same due to various reasons. Hence, once again you are informed to reinstall the Biometric machines at your college in consultation with the personnel of the Telangana State Technology Services, Hyderabad (detailed address is given below) and **send the compliance report to the undersigned immediately.**
