- 10. Prominent publicity inside and outside through Boards at vital points
- 11. Information Booklets for students/parents/staff covering ragging and indiscipline issues.
- 12. Prospectus covering anti ragging and undertaking from the students/parents/guardians.
- 13. First aid kit
- 14. Anti Ragging Help line
- 15. Anti Ragging Message
- 16. Ant Ragging Website
- 17. Anti Ragging van
- 18. Quick response teams
- 19. Sudden and surprise checks

Further, I am to inform that stern action will be initiated against the defaulting institutions.

In the light of above, I request you to bestow your personal attention in the matter and comply with the guidelines of the Hon' ble Supreme Court of India, Regulations of UGC Act, State Act provisions, etc. and to see that this academic year also would be a ragging free academic year.
