3. The tender should be submitted in a sealed covers (2 covers separately) super scribing as "TECHNICAL BID FOR DISPOSAL OF OLD VEHICLES" and "FINANCIAL BID FOR DISPOSAL OF OLD VEHICLES". Sealed tender super scribed with "Disposal of old Vehicles" on the outer cover of both envelopes addressed to the Controller of Examinations, Kakatiya University, Warangal.
4. The rates should be quoted exclusive of all taxes and duties. All statutory taxes and duties shall be charged extra on prevalent rates at the time of delivery(handover), over and above the rates quoted by bidders and shall be paid by the bidders in full.
5. The Vehicles are available for inspection from 11:00 a.m. to 03:00 p.m. on all working days.
6. No bidding firm/persons will be allowed to withdraw its bid after opening of the bids.
7. The auction of the said vehicles will be governed by the following conditions:
- The vehicles shall be disposed off to the bidders with the highest prices in the respective category of vehicle.
  - The bidders are required to pay EMD of Rs.10,000/- (Rupees Ten Thousand only) in the form of Demand Draft drawn in favour of the "Registrar, Income Account, Kakatiya University, Warangal"
  - Quotations received without Demand Draft towards EMD will be summarily rejected. No interest will accrue n the EMD so deposited.



- d) EMD of the successful bidder/s will be kept with the organization and will be returned after satisfactory completion of the order. In case of deviation of the terms and conditions, the recovery shall be made out of the EMD deposited. In case the tendered materials are not lifted with the specified date and time, ground rent equal to Rs.100.00 per vehicle per day will be charged to the successful bidder for a further period of 7 days. The vehicle not so removed will be treated as abandoned and the EMD and other sums paid for the vehicle will be forfeited without any reference to the bidder. For such abandoned vehicle, the Controller of Examinations shall have the right to resell.
- e) The successful bidder will not be allowed to withdraw their bids, failing which the EMD will be forfeited.
- f) The vehicles will be allowed to be lifted between 10 a.m. to 4 p.m. on working days of organization with the stipulated date only.
- g) The Labour, Transport and other arrangements will have to be made by the bidder at their risk, cost, and responsibility.
- h) The successful bidder or authorized representative will be allowed to take delivery.
- i) The Registrar, Kakatiya University reserves right of withdrawing from the sale of any vehicles at any stage without assigning any reasons thereof.
- j) Any loss or damage if occurred to the Institute property during the course of removing the items shall be made good at the cost of the concerned bidder.
- k) The Registrar, Kakatiya University reserves the right to accept or reject any or all, quotations without assigning any reasons thereof.
- l) All disputes relating to the quotations shall be reference to sold arbitrator to be appointed by the Registrar, whose decision will be binding on both the parties.
- m) All disputes arising out of this tender shall be subject to the jurisdiction of the court of Warangal only.
- n) Quotations without acceptance of the Terms and Conditions stipulated above are liable to be rejected
- o) Conditional Tenders and Tenders having deviation in Tender Terms and conditions liable to be rejected.
- p) The successful bidders should deposit the auction amount in online/UPI and in all forms in favour of the Registrar, Income Account, Kakatiya University, Warangal.
- q) Bid/Quotation received after the stipulated date and time will not be entertained.
- r) The delivery of the sold vehicle will be given only to the successful L-1 bidder after submission of documentary evidence in support of residential status (Voter-ID, Aadhar Card etc., in case of individual and Registration Certificate etc. in case of firm).
- s) The auctioned vehicle will be removed by the successful bidder within five working days of depositing the bid amount at his own expenses from the location of the vehicle.

- t) The vehicle will be disposed off on "as is where is basis" and no guarantee of its worthiness or quality will be given by the Department.
- u) The successful bidder will submit an undertaking to the institute along with the payment of the condemned vehicles that he will submit scraping certificate with in a period of one month to the concerned MVI of the Transport Authority with the intimation to the institute.
- v) No original documents like R.C. & Insurance policy etc. will be given to the successful bidder.
- w) If the successful bidder fails to honour the bid, offer can be given to the next bidders (L2,L3,L4...) at the rates quoted by the L1 bidder if they submit undertaking to take delivery of the vehicles as per tender terms and conditions and the EMD of the L1 bidder will forfeited and no claim whatsoever shall be entertained.
- x) The competent authority of the Kakatiya University reserved the right to award any or part or full contract to any successful agency(ies) at its discretion and this shall be binding on the bidders.
- y) In case of failure to comply with the provision of the terms and conditions mentioned, by the agency that has been awarded to contract, the competent authority of the University reserves the right to award the contract to the next bidder or any other outside agency.
- z) The successful bidder will also be responsible for getting Registration Certificate of the vehicle transferred in his name at his own cast expeditiously. The University will not be responsible for any lapses on his part in this regard.
