About Kakatiya University

Kakatiya University was established on 19th August, 1976 to fulfil the aspirations of the Telangana people for higher education. It is located in the historical city, Warangal, the erstwhile state of the Kakatiya rulers. Kakatiya University is



sprawling 672 acres of land adjoining Warangal city to serve the educational needs and its inception has heralded the long-cherished aspiration of the rural people of Northern Telangana.
