2.	Processing Fee (during I year I Semester only)	Rs. 300/- per candidate
3.	Student Recognition Fee (Per Annum)	Rs. 700/- per candidate
4.	Student Welfare Fund (Per Annum)	Rs. 50/- per candidate
5.	Inter University Tournament Fee	Rs. 60/- per candidate per annum
