Sir/Madam,

You are aware that the Government of Andhra Pradesh vide reference 2<sup>nd</sup> cited has accorded permission for creation of supernumerary seats to the extent of 20% of sanctioned seats subject to minimum of Six (6) seats, under management **quota** in the Non-technical Post-Graduate Courses (MA/M.Sc./M.Com/MHRM) of aided and unaided colleges filling up of these seats will be subject to the following conditions:

1. The College Management should admit only those students who qualify in the Entrance Test conducted by the respective Universities or those who secure 50% marks in the qualifying examination.
2. The fee payable for admission against these seats shall not exceed double the fee prescribed by the University in the regular courses in the subjects concerned.
3. The procedure of admission as given below shall be followed in order to ensure transparency and merit.
4. The 20% of sanctioned intake subject to minimum of Six (6) seats in each unaided Non-technical Post-Graduate Courses at their respective colleges shall be filled by the Managements, keeping them open to all the eligible candidates for admission including candidates belonging to other States and Union Territories of India and the NRIs, on the basis of either Rank obtained at the KU CET **OR** who secure 50% Marks in the qualifying examination.

The Managements shall not collect any other fees in the name of Development fee building fee, infrastructure development fee etc., except refundable Deposits like library deposit, laboratory deposit etc., The Managements of the colleges shall decide the programme of admission and display it on the notice board of the colleges and also give wide publicity of the same at least through three (3) leading news papers.


As such you are requested to complete the process of filling up of these supernumerary seats **for the academic year 2014-2015** by **25<sup>th</sup> September, 2014** and submit the list of candidates along with the **ORIGINAL CERTIFICATES** (with two sets of Photostat copies duly attested by the Principal and necessary fee) admitted under the said quota by the managements to the Academic Branch, Kakatiya University, Warangal in the following proforma for verification and approval of the University by **10<sup>th</sup> October, 2014** failing which a late fee of Rs.5000/- per course will be levied upto **31<sup>st</sup> October, 2014**.
