CIRCULAR

Sub: Establishment – University Teachers – UGC RSP – 2006 - **Career Advancement Scheme** – Applications for award of next higher grade (AGP), Promotion of Associate Professor/Professor – Called for – Circular – Issued.

In continuation to the Circulars cited, it is to inform that in the meantime, the U.G.C., New Delhi has notified 4th Amendment to the UGC-Regulations-2010 vide Ref. 4th cited, making some Amendments to the Minimum API Score required for extension of benefits under Career Advancement Scheme besides changing the Formats under Category-I, II and III. Consequent to the issue of said Amendment by the U.G.C., the Formats of Category-I, II and III circulated already by the University shall stand cancelled. Subsequently, the eligible teachers are requested to note the revised Format pertaining to Category-I, II and III as well as the Table (Appendix-III Table-II (A)), which shows the minimum API Score required for extension of CAS benefits at different stages.

The revised Application-Form along with Table (Appendix-III Table-II (A)) can be downloaded from the University Website.

Further, it is to bring to the notice of the teachers concerned, the following extract of 4th Amendment of the UGC :

“The second proviso prescribed under Regulation 6.0.1 in the University Grants Commission (Minimum qualifications for appointment of teachers and other academic staff in Universities and Colleges and other measures for the maintenance of the standards in higher education) (2nd Amendment) Regulations 2013 shall be substituted with the following :-

“Provided also that the API score claim of each of the sub-categories in the Category III (Research and Academic Contributions) shall not have a cap except for the sub-category of invited lecturers/papers.”

As a consequence, the table at Regulation 6.0.1 of the University Grants Commission (Minimum qualifications for appointment of teachers and other academic staff in Universities and Colleges and other measures for the maintenance of the standards in higher Education) (2nd Amendment) Regulations-2013 stands deleted.

The eligible teachers as on 30/06/2016 are requested to submit their application in quadruplicate along with all supporting documents in the revised proforma/formats along with Service book (duly updated) **on or before 15/11/2016.**
