Ph.D. ADMISSION NOTIFICATION 2026-2027
(January 2026 Session)

In terms of the K.U Orders No.1081/B3/KU/2024, dated 19/09/2024, the Faculty of Law, Kakatiya University invites applications from the eligible candidates in the following two categories for admission to the Ph.D. Programme in Law for the July Session, 2026-2027.

- (1) Fellowship holders (UGC-NET/UGC-CSIR NET/CEED/DBT/ NFPWD /DST-INSPIRE or FIP/QIP teacher Fellowships etc. (or)
- (2) NET/GATE/GPAT or similar national-level test Scorers. The validity of the NET score for admission to the Ph.D. Programme is one year.

Eligibility Criteria:

- (3) The Candidates of above two categories must fulfill the following criteria in their academic career:
 - a) A 2-year/4-semester master's degree programme (LL.M) from any recognised University after a three year degree course in law (LL.B 3 YDC) undertaken after obtaining a Bachelors' degree in any stream of study from a University or any other qualification considered equivalent by the Bar Council of India or any integrated degree course combining Bachelor' Degree course as designed by the University concerned in any stream of study together with the Bachelors' degree course in law, which shall be of not less than five years' duration (LL.B 5 YDC)
 - b) or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accreditor assure quality and standards of the educational institution and recognised and approved by the BCI, New Delhi.
 - c) A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the UGC from time to time.
 - d) Candidates who have completed the M.Phil. program in law with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of educational institutions, shall be eligible for admission to the Ph.D. programme.

A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer), Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the UGC from time to time.

Admission Process:

- i. The Candidates may obtain prescribed application form from the office of the Dean, Faculty of Law, University College of Law, K.U. Duly filled-in application form along with the necessary enclosures, a comprehensive Research Proposal and fee receipt have to be submitted in the office of the Dean, Faculty of Law, University College of Law, K.U, Hanamkonda on or before 05-02-2026.
- ii. The Registration Fee Rs.1,200/- (Rupees One Thousand Two hundred only) for OC/BC candidates, and Rs. 800/- (Rupees Eight hundred only) for SC/ST/PHC candidates has to be remitted into the "Registrar Income Account", SBI Account No. 52026911837, IFSC Code SBIN0020262 through NEFT/RTGS or Online NET Banking only. The Registration fee once paid is not refundable.
- iii. The admission into Ph.D Program is subject to the rules and regulations of Ph.D. Programme 2024-2025.
