The State Government has issued orders vide G.O. 3rd cited, revising the rate(s) of Dearness Allowance sanctioned under reference 1st cited and implemented by the University vide reference 2nd cited, to the State Government employees including teaching and non-teaching employees of the Universities in the State with effect from **1st January, 2023**, subject to the conditions as prescribed in the above said orders. The details of revision of Dearness Allowance are as follows:

Based on the G.O. 3rd cited, the Vice-Chancellor has accorded approval for implementation of the above said revised rates of Dearness Allowance to the Teaching and Non-teaching employees, including Time-Scale Employees of the Kakatiya University as per the terms and conditions as stipulated by the State Government from time to time in this regard.

All the Drawing & Disbursing Officers, K.U., are directed to take necessary action as per the provisions of the G.O. 3rd cited above and prefer the claims for payment of Dearness Allowance of the employees concerned accordingly.

Further, on account of the implementation of the said G.O. 3rd cited, Dearness Allowance shall be paid in with the salary of **June, 2025** payable on **1st July, 2025**. The arrears on account of payment of Dearness Allowance for the period from **01/01/2023** to **31/05/2025** shall be credited to the **General Provident Fund Account (GPF A/c)** of the respective employees. However, in case of employees, who are due to retire on or before **31/10/2025**, the arrears of Dearness Allowance shall be drawn and paid in twenty eight (28) equal monthly installments as the employees due to retire on superannuation are exempted from making any subscription to the G.P.F during the last four (04) months of service. In respect of Full Time Contingency/ Time-Scale Employees, the arrears may be paid in twenty eight (28) equal monthly installments from the month of **June, 2025** payable on **1st July, 2025**.

The Audit Officer (Pre-Audit), KU, shall ensure that the terms and conditions prescribed in the G.O. 3rd cited above are scrupulously followed by the Drawing Officers while claiming the amount in this regard.

The Revised Dearness Relief shall be paid along with the pension of **June, 2025** payable in the month of **July, 2025**. However, the arrears of revised Dearness Relief of the Pensioners from **01/01/2023 to 31/05/2025** shall be paid in **twenty eight (28) equal installments from the month of June, 2025 payable on 1st July, 2025**.

All the Drawing & Disbursing Officers, K.U., are requested to take necessary action as per the provisions of the G.O. 3rd cited above and prefer the claims for payment of Dearness Relief of the Pension concerned accordingly.

The Audit Officer (Pre-Audit), K.U, shall ensure that the terms and conditions prescribed in the G.O. 3rd cited above are scrupulously followed by the Drawing Officers while claiming the amount in this regard.
