Sir/ Madam,

You are aware that the Hon'ble Supreme Court and the University Grant Commission have evolved Guidelines/Regulations on curbing the menace of Ragging in Higher Educational Institutions. The Vice -Chancellor is competent to take stringent action on the ragging incidents and take all precautionary steps to curb Ragging in Educational institutions.

Against this background, I request you to take all precautionary measures for "**Prohibition of ragging and Drug Abuse**" in and outside the college especially in hostels and give wide publicity through Print and Electronic Media, Pamphlets, Banners, Notices etc. on the Guidelines/Regulations. You are requested conduct meetings with the senior students and people from the Academic Institutions, Judiciary, Police department etc., on the Act provisions and guidelines of the Hon'ble Supreme Court and the UGC on the issue of ragging.

Further, I am directed to inform you to take immediate steps to follow scrupulously, the recommendations of Dr.R.K.Raghavan Committee, as follows: -

- 1) Anti Ragging cells
- 2) Anti Ragging Committees
- 3) Anti Ragging squad
- 4) Monitoring Committee of Anti ragging
- 5) Help Desk
- 6) Emergency Call Unit
- 7) CCTV Cameras at vital points
- 8) Alaram bells
- 9) Media Campaigning
- 10) Prominent publicity inside and outside through Boards at vital points
- 11) Information Booklets for students/parents/staff covering ragging and indiscipline issues.
- 12) Prospectus covering anti ragging and undertaking from the students/parents/guardians.
- 13) First aid kit
- 14) Anti Ragging Help line
- 15) Anti Ragging Message
- 16) Ant Ragging Website
- 17) Anti Ragging van
- 18) Quick response teams
- 19) Sudden and surprise checks

Further, I am to inform that stern action will be initiated against the defaulting institutions.

In the light of above, I request you to take personal attention in the matter and comply with the guidelines of the Hon'ble Supreme Court of India, Regulations of UGC Act, State Act provisions, etc. and to see that this academic year also would be a ragging free and say no to drugs, this academic year.
